## **Insurance**

Trip coverage is NOT included in the fee. Contact OPUS for optional coverage.

## **If you cancel**

If you cancel your participation on the tour, there will be a cancellation charge that varies based on when we receive your cancellation in our office. The day of cancellation is the day on which we receive a written and signed confirmation of cancellation by fax (732 741 3040) or post (167 Hudson Avenue, Red Bank, NJ 07701). The cancellation charge is calculated according to the number of days prior to your departure date that we receive your cancellation and is listed below:

- i. There is no penalty for individual Traveler cancellation up to and including May 1, 2017.
- ii. \$250 per Traveler if notice is received after May 1, 2017 and on/before July 9, 2017.
- iii. 35% of total per Traveler if notice is received after July 9, 2017 and on/before August 9, 2017.
- iv. 50% of total per Traveler if notice is received after August 9, 2017 and on/before September 23, 2017.
- v. 80% of total per Traveler if notice is received after September 23, 2017 and on/before October 26, 2017.
- vi. 100% of total per Traveler if notice is received after October 26, 2017.

The day of cancellation is the day on which we receive a written and signed confirmation of cancellation by fax or post.

## **Notice**

Opus Tours acts only as an agent for the suppliers of travel, conveyance, transport, accommodations, or other service and has no responsibility for any delays, delayed departure or arrival, missed carrier connections, loss, death, damage or injury to person or property, or accident, mechanical defect, failure, or negligence of any nature howsoever caused in connection with any accommodations, transportation, or other services or for any substitution of hotels or for common carrier equipment, with or without notice, or for any additional expenses occasioned thereby. Baggage and personal effects are the sole responsibility of the owners at all times. The passage contract in use, when issued, shall constitute the sole contract between the company and the passenger and/or purchaser of this trip.
